Place the author's name and the page number in parentheses. Whenever you quote from or paraphrase a source in your writing, you should include an in-text citation. The basic format recommends putting the last name of the author of the source, followed by the page number, in parentheses.

[To Cite Sources on Google+:](#) On Google+, it's customary to include the name of the person or company whose content you're citing in the text of your update, because you can then link to their Google+ profile, much like you would do on Facebook. Simply include a + or @ and their Google+ name -- they'll pre-populate just like they do on Facebook.

If a DOI is available, cite the DOI number instead of the URL. Online newspapers and magazines sometimes include a "permalink," which is a shortened, stable version of a URL. Look for a "share" or "cite this" button to see if a source includes a permalink. If you can find a permalink, use that instead of a URL.

How to Cite Cite your sources both in-text and at the end of your paper. For in-text citation, the easiest method is to parenthetically give the author's last name and the year of publication, e.g., (Clarke 2001), but the exact way you cite will depend on the specific type of style guide you follow.
